

ARTICLES OF INCORPORATION
OF THE
PHILIPPINE CANINE CLUB, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all of legal age and majority of whom are residents of the Philippine, have this day voluntarily associated ourselves together for the purpose of forming a non-stock corporation in accordance with laws of the Republic of the Philippines; and we hereby certify that:

I

The name of the said corporation shall be

“PHILIPPINE CANINE CLUB, INC.”

II

The purpose for which said corporation is formed are:

Section 2.1.

To encourage and promote the breeding of purebred dogs and to do all possible to bring their natural qualities to perfection. *(As amended on October 26, 2003)*

Section 2.2.

To urge members and breeders to adhere with the breeding standards set by PCCI. *(As amended on October 26, 2003)*

Section 2.3.

To protect and advance the interests of different breeds by encouraging sportsmanship in competitions and promoting all dog-related activities such as but not limited to responsible pet ownership, owner handling, junior handling, pet grooming, agility, obedience and conformation shows. *(As amended on October 26, 2003)*

Section 2.4.

To exhaust all possible means in the promotion and maintenance of the health of pure breed dogs. *(As amended on October 26, 2003)*

Section 2.5.

To promote camaraderie among members in the pursuit of responsible pet ownership. *(As amended on October 26, 2003)*

Section 2.6.

To promote and encourage the love for dogs and to hold or arrange dog shows and competitions, and grant or contribute towards the provision of prizes, awards and distinctions; *(As amended on October 26, 2003)*

Section 2.7.

To adopt and enforce uniform rules and regulations governing dog shows and field trials, to regulate the conduct of persons interested in exhibiting, breeding and registering dogs, to detect and prevent fraud in connection therewith, to protect the interest of its members, to maintain and publish an official stud book and an official kennel gazette, and generally to do everything to advance the study, breeding, exhibiting and maintenance of the purity of pure-bred dogs; and for the purpose it shall have power to adopt by-laws, rules and regulations;

Section 2.8.

To subscribe to, become a member of and cooperate with any other association, whether incorporated or not, whose objectives are altogether or in part similar to those of this corporation;

Section 2.9.

Generally to do and perform those acts and things which are necessary, proper and incidental to the business of this corporation, and those things which are legally inherent in powers of corporation organized under the laws of the Republic of the Philippines;

III

The place where the principal office of the corporation shall be within METRO MANILA.

The corporation may establish and maintain branch office elsewhere in the Philippines or abroad whenever warranted by the exigencies of its operations and activities.

IV

The term for which this corporation is to exist shall be twenty five (25) years from now after the date of incorporations and is Hereby extended for another fifty years (50) from March 21, 1988 The expiry date *(As amended on June 16, 1984)* of the original term.

V
