Please be informed of the decisions passed by the PCCI Board of Directors last September 20, 2017 board meeting:

1. Affiliated Clubs:

- a. A dog show should start at 9:30 am or at the opening of the mall and must be finished not later than 10:00 p.m. otherwise their financial subsidy from PCCI will be forfeited.
- b. A Judge can only judge a maximum of 200 dogs per day.
- c. One-day Back-to-Back All-Breed Shows
 - i. The number of entries will be limited to 200 dogs per day.
 - ii. If a club would wish to accept more than 200 dogs, a standby judge should be provided when applying for a show. The standby judge will be paid honorarium whether he gets to judge the show or not. The honorarium of the standby judgewill be shouldered by the inviting club.
- d. One-day Triple All-Breed Shows
 - i. The number of entries will be limited to 200 dogs.
 - ii. If the club would wish to accept more than 200 dogs, a standby judge should be provided and should need to open another ring. The standby judge will be paid honorarium whether he gets to judge the show or not. The honorarium of the standby judge will be shouldered by the inviting club.
- e. For sequential or one show at a time for a triple all-breed show in Viz-Min
 - i. Entries should not exceed 80 dogs
 - If the club would wish to accept more than 80 dogs, they should open another ring.

f. JKC All-Breed Judges

- Japan Kennel Club has offered to shoulder half of the cost of the airfare of their judges that will be sent to judge at the PCCI or PCCI affiliated clubs' dog shows.
 JKC will be the one to assign a judge.
- ii. Affiliated clubs who wish to have JKC judges at their show should submit their proposed show schedule to the PCCI office.

- g. Invitation of foreign judges
 - i. Foreign judges who have judged affiliated clubs shows can only be invited after two (2) years.
 - ii. Foreign judges who have judged PCCI shows can only be invited after three (3) years.
 - iii. No sharing of foreign judges a foreign judge cannot judge on two (2) weekends.

2. Dog Shows

- a. Dogs involved in biting incident
 - i. If a dog bites a dog outside the ring but within the dog show premises/venue:
 - 1. 1st incident six (6) months suspension(the dog should be required to undergo temperament test after six (6) months to be conducted by Mr.
 Eugene Reyes. The fee for the temperament test will be shouldered by the owner)
 - 2. 2nd incident one year suspension
 - 3. 3rd incident ban for life
 - ii. If a dog attacks or attempt to bite a person:
 - 1. 1st attempt reprimand
 - 2. 2nd attempt six (6) months suspension (the dog should be required to undergo temperament test after six (6) months to be conducted by Mr. Eugene Reyes. The fee for the temperament test will be shouldered by the owner)
 - 3. 3rd attempt ban for life
 - iii. If a dog bites a person
 - 1. 1st incident six (6) months suspension(the dog should be required to undergo temperament test after six (6) months to be conducted by Mr. Eugene Reyes. The fee for the temperament test will be shouldered by the owner)
 - 2. 2nd incident ban for life
